11.1 Information on toxicological effects

- Acute toxicity: Adult male volunteers patch-tested for 48 hr with 32% citronellol showed moderate irritation. Citronellol applied full strength to intact or abraded rabbit skin for 24 hr under occlusion was moderately irritating; severe irritation was observed in rabbits and guinea pigs exposed to 100% compound (unoccluded) for 24, 48 or 72 hr.
- Skin corrosion/irritation: No data available.
- Serious eye damage/eye irritation: Citronellol resulted in moderate eye irritation in rabbits.
- Respiratory or skin sensitization: A maximization test on 25 volunteers; material tested at 6% in petrolatum produced no sensitization reactions.
- Germ cell mutagenicity: Citronellol was not mutagenic when tested in Salmonella typhimurium strains TA98 and TA100 in the presence and absence of metabolic activation.
- Carcinogenicity: No data available.

- Moderate irritation observed in adult male volunteers patch-tested for 48 hr with 32% citronellol. Contact hypersensitivity to citronellol reported in 1.2% of a selected Hungarian patient population with former skin symptoms provoked by scented products (patch tested as part of Fragrance mix II components).
