HISTOLOGICAL CHANGES PRODUCED WERE DEGENERATION OF THE EPITHELIAL CELLS OF THE SEMINIFEROUS TUBULES WITH INTERSTITIAL CELLS BEING NORMAL. IT ALSO CAUSED NEUROPATHY AS ASSESSED BY ROTAROD PERFORMANCE TEST. LD50 Rat oral 474 mg/kg
