#### 11.1 Information on toxicological effects

- Acute toxicity: Palmitic acid was a mild irritant when applied to human skin (75 mg total over 3 days). Administration of up to 10 mL/kg of commercial-grade palmitic acid to rats caused no deaths and no significant gross lesions at necropsy. Transient clinical signs, such as unkempt fur, diarrhea, and slight CNS depression were seen at 4.64 and 10 mL/kg.
- Skin corrosion/irritation: No data available.
- Serious eye damage/eye irritation: Administration of commercial grade palmitic acid to the eyes of 6 albino rabbits produced no irritation. Mild to moderate ocular irritation was produced in rabbits by product formulations containing 19.4% palmitic acid (one diluted to 75% with corn oil). Cosmetic product formulations containing 2.2 and 4.4% palmitic acid produced no ocular irritation in 6 albino rabbits.
- Respiratory or skin sensitization: In human studies, a shave cream formulation containing 2.2% palmitic acid was considered nonirritating and nonsensitizing in a prophetic patch test (101 subjects). In a modified Shelanski RIPT (52 subjects), no irritation or sensitization was observed.
- Germ cell mutagenicity: No data available.
