- Acute toxicity: Remimazolam, like other intravenously administered benzodiazepines, has not been associated with serum ALT elevations and no instances of clinically apparent liver injury from remimazolam have been reported.

Rare cases of clinically apparent liver injury have been reported with oral benzodiazepines including alprazolam, chlordiazepoxide, clonazepam, diazepam, flurazepam and triazolam. The clinical pattern of acute liver injury from benzodiazepines usually arises only after 1 to 6 months of continuous or intermittent therapy and the pattern of injury is typically cholestatic. The injury from benzodiazepine is usually mild-to-moderate in severity. Fever and rash are uncommon as is autoantibody formation. Likelihood score: E (unlikely cause of clinically apparent liver injury).
