11.1 Information on toxicological effects

- Acute toxicity: Some of the toxicities involved with ixazomib include hematological and hepatic toxicities. Hematological toxicities include thrombocytopenia, which was seen primarily during the first 3 months of treatment in the drug approval study. Platelets usually drop after a dose of ixazomib and then rise again before the next treatment cycle. Also, during the study, a small percentage of patients had to be taken off of ixazomib therapy due to thrombocytopenia. As previously discussed, there is also a risk of hepatotoxicity with ixazomib due to different hepatic injuries in patients; liver function monitoring is crucial. Furthermore, unlike other proteasome inhibitors previously reported to cause cardiac toxicity, ixazomib is not known to cause an increase in cardiac events, toxicities, or prolonged QTc interval. Ixazomib is less neurotoxic than bortezomib and less cardiotoxic than carfilzomib.
